## **Regulations for American Students Applying for Chinese-American Government Scholarship Program**

The China Academy of Art, formerly the National Academy of Arts, was established in 1928 as a center for specialist studies in the Fine Arts. The Academy is located in Hangzhou, the capital of Zhejiang province, which is one of China's most economically and culturally developed provinces. The Nanshan Campus sits beside the West Lake, Xiangshan Campus at the foot of the Xiangshan Mountain. Tranquil and visually exquisite, it is an ideal setting for the practice and study of the Arts. The Academy's seven specialist schools for studio arts, design, inter-media, public art, animation, architecture and for art and the humanities, all presently accept International Students for Master and PhD study. At present, nearly 700 international students from 90 countries are studying at the Academy.

### **ELIGIBILITY CRITERIA**

1. Applicants must be American citizens. Three copies of applicant's passport (photo page)
2. Applicants for master's degree studies at CAA must have a bachelor's degree from an accredited college or university. Provisional admission may be offered if the degree is to be completed prior to enrolling in the MFA.
3. Academic transcripts (notarized photocopy): Transcripts in languages other than Chinese or English must be attached with notarized translations in Chinese or English.
4. Four passport size 2.54×3.81cm photographs of the applicant, neutral background
5. Applicants must have been completed all required steps for admission to the IMFA program (see Admissions Information Package) and been offered admission into the IMFA program at the China Academy of Art for the coming academic year.

6. PDF file of *Foreigner Physical Examination Form* (The original copy should be kept by the applicant. The medical examinations must cover all the items listed in the Foreigner Physical Examination Form. Incomplete records or those without the signature of the attending physician, the official stamp of the hospital or a sealed photograph of the applicants are invalid. Please select the appropriate time to take medical examination due to the 6-months validity of the medical results.

7. PDF file copy of bank receipt indicating the transfer of the 800 RMB (USD\$120) application fee. Application fee must be sent directly from the applicant's home bank via wire transfer.
